## Background information

On 21 February the Prime Minister set out the next phase of the Government's COVID19 response. COVID-19 continues to be a virus that we learn to live with and the imperative to reduce the disruption to children and young people's education remains. The priority is to support schools to deliver face-to-face, high-quality education to all pupils. The evidence is clear that being out of education causes significant harm to educational attainment, life chances and mental and physical health.

## School Opening

DfE guidance for schools during the coronavirus COVID 19 pandemic has been that schools are required to have a full school opening risk assessment which is regularly reviewed and updated, treating them as 'living documents', as the circumstances in your school and the public health advice changes. This includes having active arrangements in place to monitor whether the controls are effective and working as planned.

This risk assessment applies to:

- early years
- primary schools
- secondary schools (including sixth forms)
- special schools, special post-16 providers and alternative provision
- FE colleges
- infant, junior, middle, upper schools

**Please note that this risk assessment has been created in line with the current guidance. It contains sample control measures that fit with the DfE system of controls.**

<p><b>UPDATE</b> Ventilation - failure to ensure all occupied spaces are well ventilated.</p>	<p>Staff, pupils, visitors, contractors increased risk of transmission of COVID 19</p>	<ul style="list-style-type: none"> <li>• When school is in operation, it is well ventilated with <b>comfortable</b> teaching environments.</li> <li>• Poorly ventilated spaces have been identified- doors and windows are kept open.</li> <li>• When holding events where visitors are on site e.g. school plays, ventilation is increased.</li> <li>• School has competent ventilation engineers to help assess the systems in place and how to utilise them correctly.</li> <li>• Systems should be adjusted to full fresh air or, if this is not possible, then systems should be operated as normal as long as they are within a single room and supplemented by an outdoor air supply.</li> <li>• School opens external windows, doors &amp; internal doors (if they are not fire doors and where safe to do so) to increase ventilation.</li> <li>• During colder weather, the need for increased ventilation while maintaining a comfortable temperature is balanced, opening higher vents, arranging seating away from draughts. (See <a href="#">HSE Balancing ventilation with keeping people warm</a>)</li> <li>• In cooler weather to reduce thermal discomfort caused by increased ventilation, pupils can wear additional, suitable indoor items of clothing in addition to their usual uniform</li> <li>• Purging or airing rooms as frequently as possible to improve ventilation usually when the room is unoccupied.</li> <li>• Outside space will be used, where practical.</li> <li>• <b>Co2 monitors</b> are used to help identify where a space is poorly ventilated following manufacturers' instructions. <p><b>UPDATE</b> Close contacts</p>	<p>Staff, pupils, visitors, contractors increased risk of transmission of COVID 19</p>	<ul style="list-style-type: none"> <li>• <b>From 24 February</b>, routine contact tracing will end. Contacts will no longer be required to self-isolate or advised to take daily tests.</li> <li>• School will no longer ask <b>fully vaccinated</b> close contacts and those under the age of 18 to test daily for 7 days</li> <li>• Close contacts who are <b>unvaccinated</b> are no longer required to self-isolate.</li> <li>• Children and young people who usually attend an education or childcare setting and who live with someone who has COVID-19 should continue to attend the setting as normal.</li> <li>• Contacts are advised to take precautions to reduce risk to themselves and other people: <ul style="list-style-type: none"> <li>○ minimise contact with the person who has COVID-19</li> <li>○ work from home if you are able to do so</li> <li>○ avoid contact with anyone you know who is at <a href="#">higher risk of becoming severely unwell</a> if they are infected with COVID-19, especially those with a <a href="#">severely weakened immune system</a></li> <li>○ limit close contact with other people outside your household, especially in crowded, enclosed or poorly ventilated spaces</li> <li>○ wear a well-fitting <a href="#">face covering</a> made with multiple layers or a surgical face mask in crowded, enclosed or poorly ventilated spaces and where you are in close contact with other people</li> <li>○ pay close attention to the <a href="#">main symptoms of COVID-19</a>. <p><b>UPDATE</b> Positive case unaware of new guidance</p>	<p>Staff, pupils, visitors, contractors increased risk of transmission of COVID 19</p>	<ul style="list-style-type: none"> <li>• School continues to advise adults and children who test positive to <a href="#">stay at home</a> and avoid contact with other people. After 5 days, they may choose to take a Lateral Flow Device (LFD) followed by another the next day - if both are negative, and they do not have a temperature, they can safely return to their normal routine.</li> <li>• School will encourage those testing positive for COVID-19 to inform their close contacts so that they can follow new guidance.</li> <li>• School advises those who test positive should avoid contact with anyone in an at-risk group: <ul style="list-style-type: none"> <li>○ older people</li> <li>○ those who are pregnant</li> <li>○ those who are unvaccinated</li> <li>○ people of any age who have a <a href="#">severely weakened immune system</a></li> <li>○ people of any age with <a href="#">certain long-term conditions</a></li> </ul> </li> <li>• Positive cases who need to leave home while still infectious, should take the following steps to reduce the chance of passing on the infection to others: <ul style="list-style-type: none"> <li>○ wear a well-fitting <a href="#">face covering</a> made with multiple layers or a surgical face mask</li> <li>○ avoid close contact with anyone you know who is at higher risk of becoming severely unwell if they are infected with COVID-19, especially those with a <a href="#">severely weakened immune system</a></li> <li>○ avoid crowded places. See <b>RA 026 New &amp; Expectant member of staff</b>.</li> <li>• There is no longer a legal requirement to wear a face covering in school. School follows government guidance that suggests pregnant employees continue to wear a face covering in crowded and enclosed spaces where they may come into contact with other people they do not normally meet.</li> <li>• Pregnant workers are supported by school with appropriate risk mitigations in line with recommendations provided by the workplace risk assessment.</li> <li>• In line with guidance pregnant employees &gt; 26 weeks <b>may</b> want to consider limiting close contact with people they do not normally meet with regularly.</li> <li>• School offers support by having individual discussions around pregnant workers concerns, pregnant workers are involved in the risk assessment process and school ensures they are satisfied that their continued working in the area does not put them or their baby at risk.</li> <li>• School makes sure the controls identified by the full school opening risk assessment e.g., adequate ventilation, good hygiene and cleaning, mask wearing where identified, are applied strictly.</li> <li>• Pregnant workers who continue to come into work should consider taking lateral flow tests regularly.</li> <li>• Pregnant workers should continue working only if the risk assessment advises it is safe to do so after suitable control measures have been put in place.</li> <li>• Staff who are in the <b>below</b> categories should take a more precautionary approach: <ul style="list-style-type: none"> <li>○ partially vaccinated or unvaccinated</li> </ul> </li> </ul>	<p>2x2=4</p>

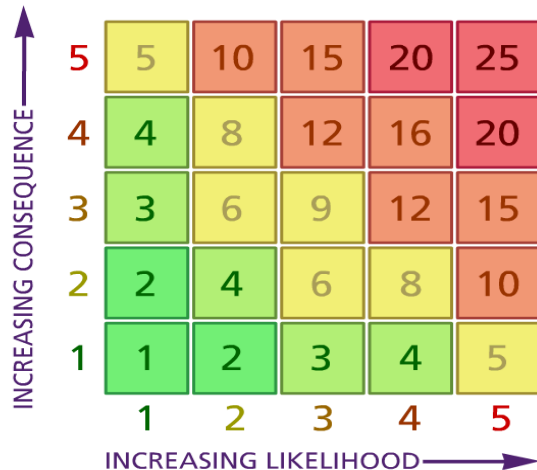
